ANNOTATION OF THE COURSE

The *subject* of study is the ethnocultural features of the mental composition and behavior of people, determined by their nationality or ethnic community, as well as traditions that have been formed historically.

Prerequisites: based on basic knowledge of history and Ukrainian culture, ethnography, art, art culture obtained while studying in secondary school and the first year of higher education.

Postrequisites: forms the ability to apply the acquired knowledge in the process of further education and professional (medical) activities and promotes the formation of a nationally conscious personality.

The purpose: to create a general concept of forming the ethnic specificity of mental activity in order to understand the psychological laws of the influence of ethnic and cultural affiliation on human life.

Main goals: mastering the peculiarities of the national culture of the Ukrainian people; factors shaping the Ukrainian mentality; learn to apply ethnopsychological knowledge in practical areas of their activity.

Results of studding: to understand the psychological aspects of the development of the Ukrainian nation, to analyze the Ukrainian spiritual and material culture in connection with the psychological features of national development.

COURSE DESCRIPTION

Forms and methods of teaching The course will be presented in the form of lectures (20 hours), practice (10 hours), students' independent work (60 hours). Consultations are individual.

When conducting lectures and seminars, *methods* are used: verbal, visual, practical; explanatory-illustrative, reproductive, problem-based teaching, part-search, research; independent work of students on comprehension and mastering of new material of work on application of knowledge in practice and development of abilities and skills, methods of the organization and realization of educational and cognitive activity; stimulation and motivation of training, control, self-control.

Content and structure of the discipline

- Theme 5. National consciousness. Mentality as an integral ethnopsychological feature of the nation.
 - Theme 6. Ethnic stereotypes. Ethnic conflicts.
 - Theme 7. Ethnopsychology of Ukrainians.
- Theme 8. Culture as the main ethno-distinguishing feature. Cross-cultural psychology.
- Theme 9. Psychology of cultural interaction. Adaptation to a new cultural environment.
- Theme 10. Theoretical problems of ethnoculture. Psychology of intercultural interaction.
- Theme 11. Mythological sources of the Ukrainian ethnocultural model: psychological aspect.
- Theme 12. Folk knowledge and moral and ethical norms of Ukrainians. Theme 13. Psychological models of Ukrainian oral folk art.
 - Theme 14. Ukrainian traditional culture: psychological dimension.
- Theme 15. The origin of the Ukrainian worldview of the XII first half of the XIV century.
- Theme 16. Formation of the idea of separateness in the psychology of the Ukrainian people in the second half of the fourteenth sixteenth centuries.
- Theme 17. Attempts to implement independence in folk psychology XVII early XVIII centuries.
- Theme 18. Folk psychology in the spiritual and political life of Ukrainian society in the XVIII century.
- Theme 19. Development of Ukrainian psychology during the national revival of the first half of the XIX century. Ukrainian national psychology of the second half of the XIX century.
- Theme 20. Psychological aspects of the Ukrainian state idea in the XX early XXI century.

CONTROL AND MARKS

Control measures include *current control*. The current learning activities of students are monitored in seminars. The following tools are used to diagnose the level of preparation of students: oral examination; test tasks; writing scientific reports. The current assessment of students takes place at each seminar (at least 30% of students must be interviewed). The current educational activity of the student is evaluated on a 4-point (traditional) scale: "5", "4", "3", "2".

The *student's independent* work, which provided in the program, is monitored and evaluated under the current supervision.

The working program of the course provides for the implementation, at the request of the student, of the student's individual independent work: 1) a student's speech with a self-prepared report on the department round of the annual university student scientific conference. 2) defense of the abstract at the seminar. 3) production of teaching aids (visual aids - maps, presentations, stands, etc.). The grade for an individual task is accrued to the student only if it is successfully completed and defended. The grade is added to the current performance. The subject of an individual task can be suggested by a teacher or a student.

As a result of studying this discipline, the student receives a "*credit*", which is set on the basis of current student activities under the following conditions: no absences or timely completion, the average score for current academic activities is not less than 3.00. The test is set at the end of the study of the discipline on the basis of current grades in the form of the average score (the arithmetic mean of all grades obtained on a

traditional scale, rounded to 2 (two) decimal places). The obtained arithmetic mean of the discipline allows you to convert to a score on a 200-point scale for further ranking on a rating scale (ECTS). According to the scores obtained on a 200-point scale, students are evaluated on the ECTS rating scale.

COURSE POLICY

The policy regarding *deadlines and retakes* is in line with the general rules at ONMedU.

Compliance with the student's *academic conscientiousness* provides for: independent performance of educational tasks. It is unacceptable in educational activities for participants in the educational process to use prohibited auxiliary materials or technical means during control events. For violation of academic integrity, students may be held academic accountable and degraded; re-passing testing, polling.

Attendance and Tardiness Policy: Attendance is mandatory. At the beginning of the lesson, the presence of students is checked. The consequence of the absence from the lesson is the obligatory further development of the topic.
