TERMS OF REFERENCE



1. Crisis Rescue Foundation in collaboration with the "Ukraine Medical Students Taskforce" have established the U.K. "CRF Ukraine Medical School U.K. Elective Programme" ("the Programme");
2. "The Programme" is a not for profit initiative which aims to take the pressure off Ukrainian medical school lecturers who have continued to deliver medical student lectures in the midst of the War in the Ukraine;
3. "The Programme" will be offering medical lectures from 4.4.22. closely aligned to the Ukraine medical students' syllabus for all years of study with a view to these lectures being recognised by Ukraine Medical Schools as a continuation of Ukraine medical school studies;
4. All lecturers will comply with the following:
 - each lecturer is a registered U.K. healthcare professional or scientist to the exclusion of any professional currently under investigation or sanctioned by any regulator or current or former employer or body with whom they were contracted professionally, or currently, and/or with any unspent convictions;
 - each lecturer is actively involved in medical education and undertakes that they have the pre-requisite knowledge and skills to deliver training on their chosen topics in the Programme;
 - each lecturer and all those participating in "the Programme" will not share any third party including patient identifiable information, and undertake to comply with all rules pertaining to information governance and GDPR;
5. Whilst "the Programme" is a bespoke set of medical lectures for Ukraine medical students wherever they may be located globally and delivered in English, we will also welcome to the lectures Ukraine Healthcare Professionals and medical students located anywhere in the World with challenges to accessing medical education due to local crises;
6. "The Programme" will run with the maximum possible collaboration with Ukraine Medical Schools professors and Ukraine government to ensure that we are delivering the right level of support to colleagues and that these lectures will be recognised by the appropriate Ukraine authorities.

STANDARD OPERATING PROCEDURE



1. Lecturers will submit their details, credentials and areas of expertise for lectures by Google Sheets to be monitored by CRF and the Ukraine Medical Students Taskforce and submitted to Ukraine Medical Schools for review and oversight along with lecture timetable and feedback;
2. A timetable of lectures specifying the topic to be covered and referenced in the Ukraine Medical Students Syllabus will be recorded;
3. The lecture series will be promoted widely including on social media and a Google Sheet will go out to all students joining to confirm their details, institution, stage of study, with evidence to be uploaded ;
4. Lectures will run using the MedAll platform and will be recorded for later viewing and revision on the CRF website;
5. All Lectures will be facilitated by a Ukraine medical student Taskforce member. This will entail arranging promotion, set up and IT pre and during the lecture, ensuring the lecture is being recorded, introducing the lecturer, monitoring the chat, relaying questions to the lecturer, collating feedback from students after every lecture, as well as ensuring the lecture keeps to time:
6. All lectures will follow a similar pattern of one hour length in total, 40 minutes of didactic lecture and 20 minutes of questions and interactive discussion with students. Lecturers will be responsible for no patient identifiable information being included;
7. All lectures will be recorded and posted on the CRF Website every 4 weeks;
8. All feedback will be reviewed post lecture and shared with the Programme team, as well as individual lecturers in order to ensure quality of lectures is maintained throughout- feedback forms questions are as follows:
 - Name of lecturer
 - Date and time of lecture
 - Topic covered
 - Overall score 0-5 for the lecture
 - What went well
 - What went less well
 - Any other comments and suggestions
